 3. A proportional pay increase for teachers who do not meet the minimum 4 instructional hours required to receive the HB2 raise, based on the percentage of time they teach according to the pay scale.

- V. Motion made by Sherrie Raughton to leave the HB2 numbers as is for auxiliary staff raises. Motion second by Heather Waters. Motion passed unanimously.
